**Directions:**

**From Ijamsville** - Ijamsville Rd. East on Rt. 80. Ridgefield is on the left.

**From D.C.** - I 270 exit 16B to Route 27 north. Follow Rt 27 through Damascus. One mile north of Damascus turn left onto Rt. 80 (Kemptown Rd). Ridgefield is about 1.5 miles on the right.

**From Baltimore or Hagerstown area** - Rt. 70 to exit 68 (Damascus).

Take 27 south approximately 1/4 mile. Just prior to the 2nd light make a right onto Penn Shop Rd.. Go to the stop sign at Rt. 80 (Kemptown Rd.). Turn left. Ridgefield is about 1/4 mile

**Rules**

1. Entry fee \$10.00 per class; Grounds fee \$10.00 per entry
2. All ages as of December 1 of the previous year.
3. Proof of negative Coggins within the last 12 months is required of all mounts.
4. Ridgefield Farm will enforce the AHSA helmet rule.
5. Cross entering is permitted according to the HCHSA rulebook.
6. Management reserves the right to combine or cancel classes with insufficient entries
7. All ponies must have a valid Measurement Card or be measured prior to their class.
8. Six ribbons awarded in all classes. Champion/Reserve Ribbons in all divisions.
9. Show management reserves the right to refuse entries.
10. NO DOGS ALLOWED ON THE PROPERTY!
11. PLEASE BRING YOUR OWN WATER
12. No schooling without intent to show

Every entry shall constitute an agreement that the person making it, along with the lessee, trainer, manager, agent, coach, driver, rider, and the horse: (1) shall be subject to rules of the Association and the local rules of the show; (2) that every rider is eligible as entered; (3) that the owner and any of his representatives are bound by the rules of the Howard County Horse Show Association (HCHSA) and the show and will accept as final the decision of the Hearing Committee on any question arising under said rules and agree to hold Ridgefield Farm, the HCHSA, their officials, directors, employees, and agents harmless for any injury or loss suffered during or in connection with the Ridgefield Farm show, whether or not such injury or loss resulted, directly or indirectly, from the negligent act or omission of said officials, directors, employees, or agents of the HCHSA or Ridgefield Farm.
