Every entry at a recognized HCHSA/Garrison Forest School competition shall constitute an agreement and affirmation that all participants (which include, without limitation, the owner, lessee, trainer, manager, agents, rider, handler, and the horse), for themselves, their principles, representatives, employees and agents (1) shall be subject to the constitution and the rules of the HCHSA and the local rules of the competition; (2) represent that every horse, rider, and handler is eligible as entered; (3) agree to be bound by the constitution and rules of the HCHSA and the Garrison Forest School, and will accept as final the decision of the hearing committee on any question arising under said rules, and agree to hold the HCHSA and the Garrison Forest School, their officials, directors, and employees harmless for any action; (4) agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk of serious injury or death, by participating they expressly assume any and all risks of injury or loss, and they agree to indemnify and hold HCHSA, the Garrison Forest School and their officials, directors and employees and agents harmless from and against all claims, injury or loss suffered during or in connection with the competition, whether or not such claim, injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officials, directors, employees or agents of HCHSA and the Garrison Forest School.
